Product recall: Vernacare wetwipes and personal cleansing goods

Vernacare have issued a precautionary recall for all in date wetwipes and personal cleansing products as part of an ongoing Pseudomonas investigation. They have also stopped the manufacturing of these goods until the route cause can be found.

The products affected include bedbaths, shampoo caps, cleansing wipes and barrier cloths to name a few. They can be purchased from high street and online retailers such as Amazon.

Please do not worry if you use any of these products. The recall is voluntary by Vernacare, but you should follow the below advice.

Check your stock

What to do if you find a recalled product

If you find an affected product and it is in date, then you should:

- Stop using it at once and place all stock to one side away from other items
- Return the affected items to either the retailer you purchased them from or Vernacare
